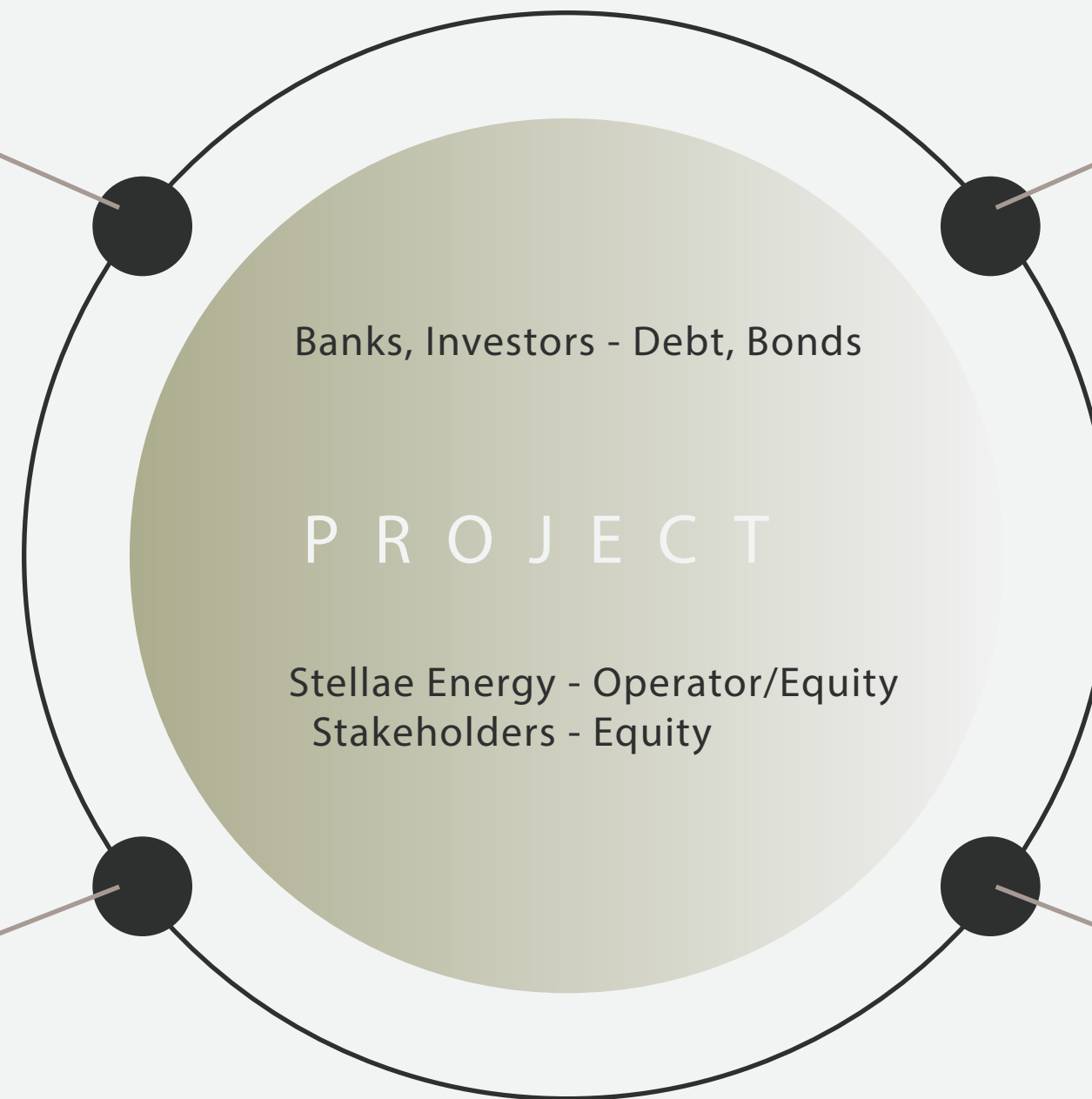

Stellae Energy - Providing equity participation though day rate or fixed cost consulting work with direct or back to back contract through local partners for the project

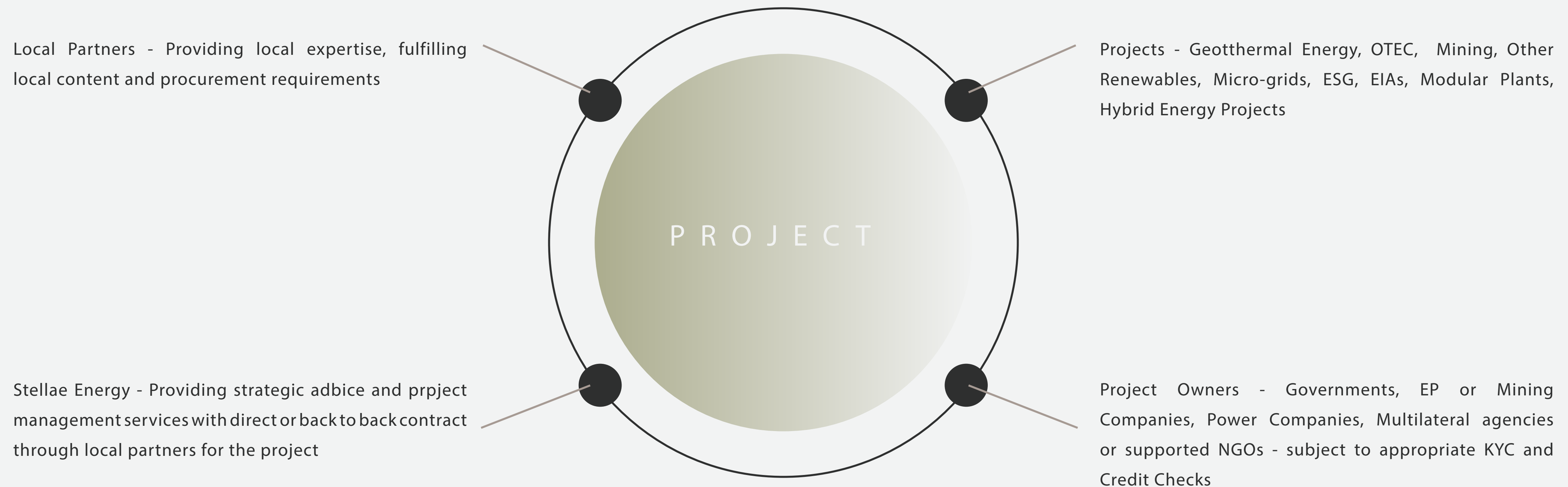
